## Student Photo Contest



### **George Ranch Historical Park**

George Ranch Historical Park (GRHP) invites <u>all</u> student photographers ages 5 – 17 to submit their favorite shots taken at the Ranch to our Student Photo Contest. Judges will select the top 4 winners in each age group category (see entry form) plus 1 overall Grand Prize winner for award and publication in the GRHP 2015 Calendar. This first annual calendar will applaud both student talent and the beauty of our Historical Park and will be available for purchase to raise funds to support our educational programs. Deadline for submitting photographs is **July 31, 2014**, so the race is on! Contest winners will be announced on **August 15.** All winning photographs will be published in the 2015 calendar. All winners will receive a certificate and four tickets to our Texian Market Days Festival. The Grand Prize Winner will also receive a copy of the calendar.

#### **RULES:**

- Entries limited to amateur photographers only
- Students must be age 5 17 years on January 1st 2014
- All entries MUST be photographs taken within the Historical Park between August 1st, 2013 and July 31st 2014
- The subject of each photo entry must fit into one of the following categories:
  - a. 1830s site
  - b. 1860s site
  - c. 1890s site
  - d. 1930s site
  - e. Park Nature
- Entry fee is \$5 for up to one photograph in each category—five photographs total. Additional photographs may be submitted for \$5 each and there is no limit to the number of entries per person. A person submitting 5 photographs—one taken at each site will pay an entry fee of \$5 total. A person submitting 5 photographs—all of the stock farm (all taken at one site) will pay an entry fee of \$25 total.
- Photographs must be submitted in digital format JPEG or JPG. Entries may be emailed to photocontest@georgeranch.org or submitted on a CD. All digital files

- must be 10 megabytes or smaller and e-mail entries should be e-mailed individually to assure they are received.
- Employees of the Fort Bend Museum Association or the George Foundation and their families are ineligible.
- Previously published photographs are ineligible.
- Entrants must submit a registration form and photo release for entries to be considered.
- All photographs submitted become property of Fort Bend Museum Association, George Ranch Historical Park, which reserves the right to publish, sell or otherwise use photographic images.
- Photographic entries must be received by the George Ranch Historical Park by midnight, July 31st, 2014.
- All decisions of the judges are final.
- Failure to comply with contest rules will result in disqualification.
